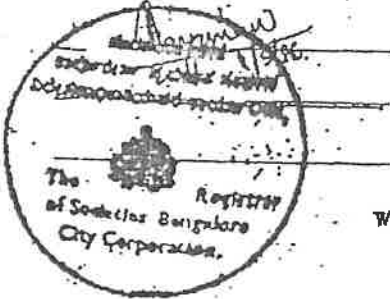

BYE-LAWS OF THE SOCIETY

- 1) Name of the Society : MOTHER'S CARE EDUCATION SOCIETY (R)
- 2) Office Address : No.2362, MIG., 3rd Phase, Yelahanka New Town, Bangalore - 560 064.
- 3) Aims and Objectives : Aims and objectives of the Society Shall be:

Promotion of Education, Science, literature, Fine arts, Sports, and for any purpose specified in section 3 of the Karnataka Societies Registration act, 1960.

- a) To conduct Adult education and Anganwadi and Balwadi schools for children.
- b) To conduct classes in fine arts, musical and dance.
- c) To establish within state of Karnataka schools, colleges and free hostel.
- d) To introduce any possible improvement in the system of education in its institution from time to time.
- e) To organize whenever necessary public opinion on matters of educational importance.
- f) To issue bulletins or journals to publish books, pamphlets or dissemination of useful information to its institutions.
- g) To promote and work of women such as stitching, embroiding tailoring and domestic work.
- h) To provide facilities for education and physical training.
- i) To promote science, fine arts literature and to impart useful knowledge.
- j) To create and foster a general interest in education among scheduled caste and in particular backward communications in general to give

them special facilities, scholarships, and free ships for higher education.

- k) To provide hostel facilities for the students and for working women's and old age home (Vridhashrama) for a aged persons.
- l) To promotion of establishing circulating library, reading room, other teaching institution.
- m) To conduct dramas, festivals and other useful activities.
- n) To undertake special programme for children's such as health, education and habit of build of vocational training.
- o) To conduct Rajyothsava and Ganeshothsava, Anbedkar Jayanthi festivals and all national festivals.
- p) To promote sports rally to conduct motor cross world touring on motor cycle race etc.,
- q) To protect and promote the common interest of its members and making them a worthy citizen of the nation.
- r) To educate people to unit among themselves to conduct various programme in the field of economic health, educational, cultural and many other fields.
- t) To do all other lawful things and acts as incidental or conductive to the attainment of the aforesaid aims and objectives.
- t) The profit if any or other incomes is to promote their objects profits and the payment of any dividend or distribution of any income or profit among their members is permissible if required.

- 4) Membership :
- (a) Any person above the age of 18 years shall be eligible for admission as a ordinary member, with the approval of the committee
 - (b) Every such member shall on admission pay on admission fee of Rs.2/- each Per month.
 - (c) Application for membership shall be addressed to Secretary, Every such application for admission shall be considered by the president in consultation with the Managing committee who shall have power to admit or to refuse the admission.
- 5) Cessation of Membership : Any member of the society shall cease to be a member of the society.
- a) By withdrawal.
 - b) Removal or expulsion.
 - c) Death or for the reasons mentioned in the societies act and rules in Karnataka.
- 6) Borrowings: It shall be competent to the committee of management or any authorized member of the to borrow / raise funds for the over all improvements and providing job opportunities etc. In approaching state, Central Government/Banks etc., to promote interests of the society and to expand its activities.
- 7) Chief Patrons: The managing committee on the advice of the president may nominate any two important persons of the public life as chief patrons of the society if required.
- 8) Management: The management of the affairs of the society shall consists of 7 members or more. The members of the committee of management shall be elected/nominated by the General body/president of the society once in every 2 years or earlier to that depending on the necessity.

The committee of management shall ordinarily meet once a month or as may be necessary to conduct the affairs of the society. The secretary

in consultation with the president shall convene the Committee meeting. A notice of at least 4 days shall be normally be given to the members of the Managing Committee.

Quorum : for the meeting of the managing committee shall be 4. No quorum is required for the adjourned meeting, duly notified. Should be a member of the committee absent himself without valid reasons for 3 consecutive meeting. He shall loose to be a member of the committee.

The subjects before the committee shall be decided by a majority of votes however incase of equality of votes the president shall have a casting vote. The voting shall be conducted by raising hands.

It shall be competent to constitute sub-committee from among the committee of management of among other ordinary members for the promotion and efficient execution of business of society. The committee of management consists of (1) President (2) Secretary.

9. 1.PRESIDENT :

The president shall have a general control over all affairs of the society including administration. He shall whenever present preside over the meeting of the committed of management as well as the general body meeting. He shall have power to call special general body, if necessary. The president and secretary shall sign cheques and other financial transactions on behalf of the society, or any one of them by obtaining the required authorization by the committee.

2.SECRETARY :

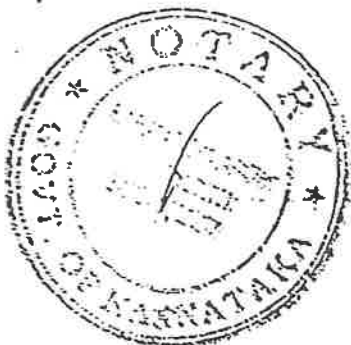
The secretary shall be responsible for the executive administration and day-to-day affairs of the society subject to the control of the president. The secretary shall be officer to use or to be used on behalf of the society. The secretary is to convene and to attend the meeting of the committee and general body meeting as resolved by the committee and duly record the proceedings for such meetings and to carry out the resolutions passed, He is to prepare annual statements and other returns that may be prescribed under the rules of the society and or by the registrar of societies. All the documents, records, stocks and other properties of the society shall be in the custody of the secretary.

10. General Body Meeting: General Body of the Society shall meet atleast once in a year to conduct the affairs of the society. The general body however shall not interfere with actions of the committee of management done in the exercise of powers conferred and then by the by-laws. The quorum for the general body shall be not less than 1/3 of the members on the roll. Atleast, 7 days notice shall be given to the members for general body meetings. A special general body meeting shall be convened if necessary as per section 11 (3) of the K.S.R. Act 1960.
11. Accounts: The accounts of the society (official year) shall be from 1st January to the December every year or as per the administrative convenience.
12. Auditor/Chartered Accountants : Shall be appointed annually to prepare the balance sheet and accounts etc, which shall be submitted to the registrar as per section 13 of the K.S.R. Act 1960.
13. The Committee of Management : Shall consider all affairs of the society subject to section 5 of the K.S.R. Act 1960. The committee of Management shall fix a honorarium monthly payment to the president and secretary and also bata payments to others members of the managing committee of their presence for the committee meetings. All the above payments shall be made subject to the availabilities of the financial funds. A resolution to this effect shall have to be passed in the committee meetings.
14. Alterations or amendments to the memorandum of Association shall be made as per section 9 of K.S.R. Act 1960.
15. Change of name, rules and regulations shall be made as per section 10 of the K.S.R. Act 1960.
16. For all other things and matters which have not been specified for herein above, the provisions of the Karnataka societies Registration Act, 1960 and the rules made there in under shall apply.

17. Take-up rural development activities by the society for the upliftment of weaker sections of the society, irrespective of Caste, Creed & Sex restrictions.
18. Take-up any kind of health improvement programmes such as family planning Aids prevention and after care activities, Alcoholism, drugs de-addition & vaccination programmes, etc., both by State and Central Govt. or by any agency to the medical requirement of the needy & deserving public. To work in the field of health, sanitation environment, drinking water schemes rural development programmes, consumer awareness programme. Women welfare schemes, important activities for women welfare schemes important activities for women by formation of self help groups also. Welfare activities for old aged persons, for handicapped retarded etc., legal redressed services as well as those need based socio-economic upliftment activities for any targeted groups irrespective of caste creed and sex.
19. Any amendments to these bye-laws can be made by the majority decision of the committee.
20. The working hours of the society shall be 9 a.m. to 11 a.m. and 5 p.m. to 7 p.m.
